Mr. [REDACTED] advised that someone in the group was recording the interaction on a cell phone. Mr. [REDACTED] was advised by Reverend Bellan-Boyer that [REDACTED] Short Hills, NJ 07078 was listed as the...

Headquarters for the Serruto/Henrichs Campaign for Millburn Township Committee. Mr. [REDACTED] was given an invitation pamphlet by Reverend Bellan-Boyer to join them at Moonshine Modern Supper Club - 55 Main Street Millburn, NJ 07041 today 10/12/2025 at 2000 hours. Mr. [REDACTED] was also given written letters to Mr. Jamie Serruto and Mr. Kris Heinrichs regarding their issues. Mr. [REDACTED] advised that he wasn't interested and advised the group of (5) men to leave his property, which they complied. Mr. [REDACTED] advised that the (5) men left the area in a Black Ford Econoline Van with a Fountain Baptist Church logo on the side. Mr. [REDACTED] advised that he is on the no knock list for soliciting in Millburn Township and doesn't want anyone affiliated with Fountain Baptist Church soliciting at his residence. Mr. [REDACTED] provided CCTV of Reverend Bellan-Boyer at his front door. Mr. [REDACTED] provided the Moonshine Modern Supper Club invitation pamphlet and letters written to Mr. Serruto and Mr. Heinrichs, which will be entered into Records at Millburn Police Department.

I relayed the vehicle description to Officer Genitempo and advised him to check the area of Moonshine Modern Supper Club. Officer Genitempo located the 2011 Black for Econoline Van bearing New Jersey registration XW219X parked on Main Street, which came back to the registered owner of Fountain Baptist Church - 116 Glenside Avenue Summit, NJ 07961. I advised Officer Genitempo of the incident and that I would meet him at Moonshine Modern Supper Club to attempt to make contact with Reverend Bellan-Boyer and the group that were at Mr. [REDACTED]'s residence.

I responded to Moonshine Modern Supper Club and located Reverend Bellan-Boyer and his group inside of the establishment and advised them to step outside of the establishment, so I could speak with them. I spoke with the group and they confirmed that they were at Mr. [REDACTED]'s residence of [REDACTED]. I advised the group that Mr. [REDACTED] is on the no knock list for soliciting in Millburn Township and doesn't want anyone affiliated with Fountain Baptist Church soliciting at his residence. I advised the group that Mr. [REDACTED] advised that his home address is not the listed as the Headquarters for the Serruto/Henrichs Campaign for Millburn Township Committee. The group advised that [REDACTED] is listed on the campaign website <https://voteformillburn.com> and showed me, which was confirmed. The group acknowledged that they would not respond to [REDACTED] residence again as per the Millburn Township Ordinance 4-8.6 Nonsolicitation List.

I responded back to Mr. [REDACTED]'s residence and advised him of my contact with Reverend Bellan-Boyer and the group that was at his residence earlier. I also advised Mr. [REDACTED]'s that his address is listed on the the bottom of the website <https://voteformillburn.com> for the Serruto/Heinrichs Campaign for Millburn Township Committee. I advised Mr. [REDACTED] that the group advised that they will no longer respond to his residence again as per the Millburn Township Ordinance 4-8.6 Nonsolicitation List. Mr. [REDACTED] was satisfied and advised that he would have his home address removed from the website.
