- To vote for any person whose name is not printed on this ballot, darken the oval by the words "write-in" for the office in which you want to write-in. Write the name of the person for which you wish to vote on the blank line.
- Once you have completed voting this ballot, place the marked ballot in the inner envelope and seal it closed. Complete the attached affidavit and sign your name where indicated; place the completed inner envelope inside the return envelope addressed to the Burlington County Board of Elections and mail.
